SUBJECT: HOUSE RULES



1. The privilege of being admitted into the Social Quarters is as follows:
 - a. Members in good standing of Horace Orr Post 29, Inc., showing a current membership card of The American Legion, The American Legion Auxiliary, American Legion Riders or The Sons of The American Legion.
 - b. Members in good standing of any post of The American Legion showing a current membership card in The American Legion, The American Legion Auxiliary, or The Sons of The American Legion.
 - c. A Post 29 member in good standing is allowed 2 guests that must be signed into the guest book by the member. Additional guests are allowed with prior approval by the Post Commander or Junior Vice Commander.
 - d. Immediate family (spouse and/or children) and all Guests who are eligible to join the American Legion, American Legion Auxiliary, or Sons of the American Legion are restricted to a total of three (3) visits to the Social Quarters as a guest in any calendar year. The sponsoring member is responsible for determining membership eligibility with respect to these provisions and will inform his and/or her guest that joining the American Legion and/or its recognized affiliates will determine their future visitation rights.
 - e. The member who registers the guest will be responsible for that guest and their actions during that visit. If the member leaves, the guest must leave.
2. Certain Areas are posted as restricted to Post 29 Members Only. These include the Game/COAM Room and the Poker Room. Guests may pass through these areas but may not linger. You must be a current member of Post 29 to play any of the games in the Game or Poker rooms. Individuals will play at their own risk. The Post is not responsible for any malfunctions of the machines or personal items left in the game room. Individuals that have issues with the machines must report these issues to the Commander or Bartender.
3. Children under 16, even members of Horace Orr Post 29, Inc., must be accompanied by an adult member. Children under 12 are not permitted in the lower-level areas of the Post after 7PM.
4. This is a NON-SMOKING facility. Smoke only in designated exterior areas. No one under the age of 18 is allowed anywhere smoking is permitted, even if no smoking is currently taking place.

5. Appropriate attire is expected. Shoes, shirts, shorts, or pants are required. Men's shirts must have sleeves unless part of an official Legion uniform. Any Clothing deemed inappropriate is not permitted. This includes clothing that is overly suggestive or revealing, vulgar or offensive, in a state of disrepair or appears to be in bad taste is not permitted. The final decision as to what constitutes proper dress rests with the Executive Committee.
6. All members are expected to help keep the Post clean and tidy. Outside food for personal consumption is allowed. Food brought for distribution to all must be approved by the bartender on duty.
7. The bartender on duty or any Post Officer shall have full authority to enforce the House Rules and may remove a member or guest from the facility for inappropriate behavior, dress or intoxication. The bartender on duty may refuse service to anyone for reasonable cause. Refusal to leave the premises when requested by authorized Post personnel can result in being escorted off the premises, suspension of privileges, or other disciplinary action up to and including arrest by law enforcement and filing of criminal charges. Removal can also be due to safety concerns or crowding. Any person asked to leave may appeal to the Executive Committee, if done in writing within (limits for the appeal).
8. No member shall reprimand an Officer or any employee of the American Legion. Any suggestion or criticism of the Social Quarters or Legion operation shall be submitted to the Executive Committee in writing, signed, and dated by the individual submitting the report to the Post Commander. Any unsigned reports will not be considered.
9. Any member or their guests removing without permission, damaging, or destroying any property of the Post shall be reported to the Executive Committee. Damages will be assessed, and suspension will be considered.
10. Cashing of checks is limited. See the bartender for details and approval. Credit card transactions will not be for "Cash" or "Cash Back". An ATM is located on the premises.
11. No alcoholic drinks of any kind will be taken from the premises. No outside alcohol may be brought onto the premises.
12. No alcoholic drinks will be served/given to anyone that appears to be intoxicated or under the age of 21.
13. Animals will not be allowed in the Post. Certified Service Dogs, prescribed by a physician, shall be considered for exception. Documentation must be provided to the bartender on duty or a Legion Officer.
14. Loud, profane, threatening language or actions "unbecoming" will not be tolerated.

15. Lewd, indecent, or sexual misconduct/harassment will not be tolerated.
16. The Social Quarters hours and days of operation are published in the newsletter and the Post website. The Executive Committee via the Junior Vice Commander for Social Quarters may approve and announce changes to the days of operation. The Social Quarters Manager or bartender on duty may temporarily change the hours of operation based on circumstances.
17. No firearms, knives, or weapons are permitted in the Post or on the property.
18. Members may file a complaint or report of misconduct to the Executive Committee. These should be completed within 48 hours of the incident, placed in a sealed envelope and submitted in person to a member or the Executive Committee.
19. The rules listed above may be amended, changed, or modified at any time by the Executive Committee as the need arises. On update of any rule, the header date will reflect the most current modified date; the executive board at that date is the approval authority.
